**Directions:** All generations must be filled in and proven from you to your ancestor. Proofs will be seen only by the Registrar examining this application; these documents will be destroyed after verification or returned to you, if you include a self-addressed, stamped envelope with this application. Your application will be filed with those of others who register their ancestors and will be available for those who research early Henry County residents.

Acceptable proofs include: birth and death certificates; Bible records; will and estate distribution records; census records; approved record copies from other hereditary organizations; land records; and well-sourced, published materials.

The cost to register your first ancestor is \$30; additional ancestors may be registered for \$20 each. Please make checks or money orders payable to GSHCC, Inc. If your registration is approved, you will receive a certificate naming you as a descendant of one of the first families of Henry County, Georgia. Your name and that of your ancestor(s) will be added to the First Families plaque that hangs in the Society's headquarters.
